STATE OF WEST VIRGINIA, COUNTY OF MARSHALL, CITY OF CAMERON, CITY COUNCIL, REGULAR SESSION JANUARY 9, 2012

The City Council of the City of Cameron met in Regular Session on January 9, 2012 in council chambers of the Benedum Community Building. Mayor Mark Frazier called the meeting to order at 7:00 p.m. The following council members were present: Rocky Guzek, Tom Hart, Chris Hartley, and Wayne Simmons. Absent – Helen McMasters, Ron Walker.

PLEDGE OF ALLEGIANCE: Led by Tom Hart.

SCHEDULED ON AGENDA: Randy Watson, Thrasher Engineering, was present and gave an update on the water line project. No pay estimate was presented for the January 9, 2012 meeting. They do not have to cut the trench on each side the extra foot out Green Valley as originally thought. It is cheaper to lay the overlay in the spring and Kevin Kaufman agreed to let the project proceed as such. They are going up Isiminger Lane and crossing over Big Grave creek and on up Green Valley to tie back into the 4 inch line. There may be residual funding available to contribute toward upgrades at the current water plant.

Chris Hartley queried as to if this was acceptable. Randy replied yes, since it involves the water system that it should get approved but they may not want to contribute a great deal of funding to it. Randy will write a request to the Regional Council for approval of the change request to include the upgrades.

Chris Hartley asked if there was a completion report that gets submitted. Randy replied that a Substantial Completion report gets done but nothing that he submits.

Randy presented Change Order #2 to reflect the reduced rate of \$77.00 per foot, which was originally presented at a higher rate. Anderson was not available to bring the change order to Council. Randy brought one copy with him for review. Revised Change Order #2 with the increase of \$95,742.95 was presented for approval.

Motion to approve the Revised Change Order #2 was made by Wayne Simmons. Seconded by Tom Hart. Motion carried.

PUBLIC COMMENT:

APPROVAL OF MINUTES: A motion to approve minutes of December 5, 2011 with noted corrections was made by Tom Hart. Seconded by Rocky Guzek. Motion carried.

FINANCE REPORT: Not Available

STREETS/ALLEYS/LIGHTING: Flag light is out and needs replacing.

POLICE: A police report was available for the month of December.

VEHICLE MAINTENANCE: Mayor Frazier reported that all vehicles are running fine.

WATER: The impact of the water line project has reduced the over-time at the water plant and the water supply has increased tremendously.

Chris Hartley suggested that we do some work on the water tank. The outside needs to be painted.

Mayor Frazier suggested that the inside needs to be clean but may not be feasible with it being the only water tank in town. This type of project would take several days.

Rocky Guzek added that the aerator needs to be fixed. Mayor Frazier added that PZ says we have an In-Line Mixer and that it is already being mixed.

Emergency Services/Publicity – Tom Hart – advised that the design was complete and once the invoice is received, a check will be cut and the steel for the tower should be ordered later this week. The steel will take 8-10 weeks to get in. Construction should start no earlier than the first of April. Premier Construction will do the construction of the tower. All agreements have been signed with AT&T. The tower should be up and functional by September.

Rocky Guzek inquired if the EPA tests were completed and Tom Hart replied that they were done. Everything was complete.

Mayor Frazier reminded everyone that it was a volunteer effort and that he did not have a problem with it, but may be something to review for next year.
