

**STATE OF WEST VIRGINIA, COUNTY OF MARSHALL, CITY OF CAMERON,
CITY COUNCIL, REGULAR SESSION, MARCH 3, 2014**

The City Council of the City of Cameron met in Regular Session on March 3, 2014 in council chambers of the Benedum Community Building. Acting Mayor Sheila Cottrell called the meeting to order at 7:00 p.m. The following council members were present: Tom Hart, Wayne Simmons, Helen McMasters, and Ron Walker. Jack Hart, Sr. and Rock Guzek, absent.

PLEDGE OF ALLEGIANCE: Led by Wayne Simmons.

FINANCE REPORT: Wayne Simmons read the Finance Report – General Fund \$206,413.88, Water Fund - \$28,842.15, and Sewer Fund - \$2,090.94, Total \$237,346.97.

POLICE REPORT: None.

VEHICLE MAINTENANCE: Sheila Cottrell advised that the equipment had been repaired and was operational.

STREETS/ALLEYS/LIGHTING: Discussion was had concerning the slip and drainage problem at Frank Temple's residence. Sheila Cottrell presented council with an estimate for repairs by Q&M Construction totaling \$4,500. Ron Walker made a motion to approve the estimate, Helen McMasters seconded.

WATER/SEWER: Tim Flint advised that the chlorine system had been repaired at the water plant, and that things were running smoothly. Sheila Cottrell advised that there were no issues at the sewer plant.

APPROVAL OF MINUTES: A motion to approve minutes from the February 24th meeting was made by Helen McMasters, seconded by Ron Walker.

OLD BUSINESS: Sheila Cottrell will call Marshall County Chamber of Commerce to see if some of the local businesses can be listed since the City is a paying member.

Sheila Cottrell will have Terry Springer check to see if there is blockage in the drain near the City Building.

Ron Walker suggested getting a price for a new salt spreader and plow.

NEW BUSINESS: It was reported that the street is breaking off right before the steps near the Harold Lewis property. Sheila Cottrell will call the DOH regarding this problem.

PUBLIC COMMENT: Greg Galentine voiced concerns regarding use of City equipment, and gravel covering storm sewer at end of Fleming. Brian Marling inquired regarding sewer problem near his business and his Mother's property, and was advised Rosemary Humway-Warmuth is to review right of way agreement. Jeff Beresford addressed Greg Galentine's concerns.
