CITY COUNCIL, REGULAR SESSION, JULY 19, 2021**

The City Council of the City of Cameron met in Regular Session July 19, 2021, from the Benedum Community Building. Mayor H. Greg Galentine called the meeting to order at 7:00 p.m. The following council members were present: Joseph Wendt, John "PZ" Winters, Sherry Johnson, Kenny Richmond, and Terry Galentine. APPROVAL OF MINUTES:

- 1) Councilperson Kenny Richmond moved to approve the minutes as presented on July 7, 2021, meeting, seconded by Councilperson Joseph Wendt. Motion carried, vote of 5 yes.
- 2) Councilperson Sherry Johnson moved to approve the Special Meeting minutes as presented on July 7, 2021, seconded by Councilperson PZ Winters. Motion carried, vote of 5 yes.
