# Low and Very Low-Income Homebuyers

### **Direct Loans**

- Offered directly by USDA
- 33-year fixed interest rate (typical term)
- Applicant's income must be below local low- or very low-income limits determined by USDA
- Payment assistance may be available
- Apply at your local USDA Rural Development office.

# Moderate-Income Homebuyers

### **Guaranteed Loans**

- Offered by lenders such as banks, and guaranteed by USDA
- · 30-year fixed interest rate
- Applicant's income must be below local moderate-income limits determined by USDA
- · Apply with a local USDA-approved lender

# Are You a Homeowner Needing Help?

## Repair or refinance with 0% down and 100% financing

USDA Rural Development offers homeowners in <u>eligible rural areas</u> two great opportunities:

## Home Repairs

- Offered directly by USDA for properties located in eligible rural areas
- · Loans at 1% interest
- Grants available for those age 62 or older with no loan payment ability
- Applicant's income must be below local low- or very low-income limits determined by USDA
- Apply at your local USDA Rural Development office.

# Refinancing

- Offered by lenders such as banks, and guaranteed by USDA
- Current financing must be a USDA Guaranteed or Direct Loan
- Household income must be below local moderate-income limits determined by USDA
- · Apply with a local USDA-approved lender

#### **USDA RURAL DEVELOPMENT PRE-QUALIFICATION PROCESS**

This is the first part of the loan process that we use to review unverified information to see if there is an opportunity for you to obtain a loan through our Rural Housing Service (RHS) program. This gives us a chance to:

- \* Explain our program
- Review your income, monthly debts and credit history to determine your eligibility.
- Calculate your estimated maximum loan amount and monthly loan payment

In order to start this process, you must complete the following:

- 1. Complete all items which apply to your household, on the "PRE-QUALIFICATION INFORMATION" sheet.
- 2. Sign the "AUTHORIZATION TO RELEASE INFORMATION" RD 3550-1 All household members 18 years of age and above must sign a separate form. (Signing this authorizes the release of information needed to process your request).
- 3. Please provide copies of proof of income for <u>all</u> household members. (e.g. Paystubs or Award Letters)
