### **APPROVAL OF MINUTES:**

Councilperson Sherry Johnson moved to approve the Minutes for April 15<sup>th</sup> and for Special Meeting held on April 16<sup>th</sup>, 2024, seconded by Councilperson Stephanie Neely. Motion passed 4 YES.

## **PUBLIC COMMENTS:**

 Casey Young from The Thrasher Engineering Group spoke with the council regarding upcoming project progress.

The design phase is in discussion of finalization stages. Back and forth with DOH and Thrasher. Since multiple projects will be completed in and around the same areas the two are working together to not finish one project and turn around and tear it up to complete the other project. Also looking into traffic control during projects. Should come to some resolution within the next couple weeks.

County Commissioner has the \$350,000.00 Phase III Water Project request on their May 21<sup>st</sup>, 2024, agenda to be voted on.

Sewer line issue found on Green Valley Road. City Crew currently working on it, Casey from Thrasher went to site to observe and will be in touch with contractor who completed the work Green Valley Water Extension Project.

Ground sampling and surveys have come back from the water tower location. Everything has passed and is good to go to install the two new tanks.

Casey was also going to sewer plant to access the grit chamber due to it not working properly and to look into possible next steps to get it fixed.

Wastewater Operator Jeff Gardner wants to discuss with the council some issues that have come up at the plant. Recently the plant pump motors are not cycling due to debris (rags, diapers, shirts) being flushed down toilet, which that get lodged into our NEW pumps. Looking into options to fix this problem. Before we lose a pump due to debris.
